EXHIBITOR HARDWARE ORDER PROGRAM

• This offer is only for Select and Premier members of Apple's Developer programs. Developer agrees that the hardware purchased through this program will be used for exhibiting at the show. Please note that all applications for purchase will be reviewed to determine eligibility. Developer's attempt to purchase hardware through this program without participation and will result in a forfeit of future eligibility for hardware discounts. In these cases, Apple also reserves the right to refuse future access to the Apple Developer Connection (ADC) Hardware Purchase Program.

• All terms and conditions of the Developer's current authorization contract with Apple apply, (see below) and are incorporated into this Order Form. To the extent that there is any conflict between those terms and the terms of this Order Form, the terms of this Order Form shall govern.

If you intend to participate in the Hardware Order Program, you are required to sign and return the Apple Purchase Program terms and conditions. No equipment orders can be processed without a contract on file.

- Standard terms of sale offered are American Express, Visa or MasterCard.
- Applicable local sales tax (of the shipping destination) must be added to all orders. If you are tax exempt, attach a copy of your exemption certificate to each order. Resale certificates cannot be accepted.
- All purchases are FOB Apple's shipping location. Title to the products shall pass to Purchaser at Apple's shipping location. Prices include Apple's standard transportation, insurance and routing to U.S. locations. Apple shall ship in accordance with Apple's standard practices. When shipping pursuant to Apple's standard practices, Apple will place tracers, file claims and replace product lost or damaged in transit. If Purchaser requests product be air expressed, terms will remain FOB Apple's shipping location, but, shipments transported under Purchaser's instructions shall be "freight collect." All freight insurance, and other responsibility for the product (including any loss, damage and claim processing) will reside with the Purchaser.
- Apple will endeavor to ship items within four to six weeks after accepting your order. Apple cannot, however, guarantee shipment within this period.
- Developers agree not to resell or otherwise transfer any items purchased for a period of at least one-year from the date of shipment, and agree that all equipment ordered under the Hardware Order Program will be used for the purpose of exhibiting . Following the show, developers may use the purchase for developing software and/or hardware products that will be sold for use with Apple products.
- Developers agree to contact Apple Software Licensing before distributing any products that incorporate Apple proprietary software, and to comply with all applicable licensing requirements.
- Developers who order Apple development systems do so with the understanding that Apple may include their names in promotional mailings as being among those who are

developing third party products for Apple systems. Apple will not include any information about the types of products you are developing without your express consent.

- In no event shall Apple be liable for incidental, consequential, indirect, or special damages, including, without limitation, lost business profits or revenue.
- This Agreement and the purchase made hereunder shall be subject to, and construed in accordance with, the laws of the State of California, excluding that portion of that law concerning choice and conflict of laws.

This Agreement constitutes the entire agreement between the parties pertaining to the subject matter hereof and the purchase made hereunder. Any other written or oral agreements between the parties, or modifications to this Agreement (including any of the terms of any purchase order or other document submitted by the ADC Hardware Purchase Program or the terms of the Order Form and Purchase Contract), shall be of no force or effect as regards the subject hereof unless incorporated herein by a writing signed by authorized representatives of both parties specifically referencing this paragraph. In the event that any portion of this Agreement should be determined to be void or invalid for any reason, its remaining terms shall be interpreted so as to reflect the basic intentions and objectives of the parties.

- **Apple has a no-return policy on equipment purchases.** You may contact your Regional Support Center to request a return, and under special circumstances a return may be granted. Returns will not be accepted without prior authorization. If a return is granted, you may be charged a 15 percent restocking fee.
- I understand that Apple reserves the right to modify the terms and conditions of the Hardware Order Program at any time. In addition, Apple has the right, at any time, to revoke my participation in the Hardware Order Program, with or without cause.
