Apple Computer, Inc. ("Apple"), and Licensee agree that the following terms and conditions shall govern Licensee's use, reproduction and distribution of the WebObjects Materials (as defined below).

RECITALS

A. Apple has expended time, money and resources to develop certain WebObjects Materials (as defined below).

B. Licensee desires to obtain a non-exclusive license from Apple to use, reproduce and distribute the WebObjects Materials solely together with Licensee Products (as defined below), and Apple is willing to grant such license to Licensee under the terms and conditions of this Agreement.

AGREEMENT

1. DEFINITIONS

For the purposes of this Agreement, the following terms shall have the meanings ascribed to them below:

- 1.1 "Anticipated Release Date" means the date the Licensee anticipates to commence distribution or shipment of the Licensee Product incorporating the WebObjects Materials as indicated by Licensee in Exhibit A hereof.
- 1.2 "Apple Technology Web Badge Trademark License" means the terms under which Apple agrees to license its Technology Web Badges, as such terms are set forth at the following URL:

- 1.3 "Apple Technology Web Badge Usage Guidelines" means the criteria under which Apple allows third parties to use and display its Technology Web Badges.
- 1.4 "Confidential Information" means: (a) any information, including but not limited to any information relating to either party's product plans, designs, costs, prices and names, finances, marketing plans, business opportunities, personnel, research, development or know-how, that is designated by the disclosing party as confidential in writing or, if disclosed orally, designated as confidential at the time of disclosure and confirmed as confidential in writing within thirty (30) days of disclosure; and (b) the terms, conditions and existence of this Agreement; provided, however that "Confidential Information" will not include information that: (i) is now or subsequently becomes generally available to the public through no fault or breach on the part of the receiving party; (ii) the receiving party can demonstrate to have had rightfully in its possession prior to disclosure by the disclosing party hereunder; (iii) is independently developed by the receiving party without the use of any Confidential Information of the other; or (iv) the receiving party rightfully obtains from a third party who has the right to transfer or disclose it.
- 1.5 "Distributor" means an individual, person, organization or entity that is licensed or authorized by Licensee: (a) to distribute Licensee Products directly to End-Users, and/or (b) to sublicense other resellers to distribute Licensee Products to End-Users in accordance with the terms of this Agreement.
- 1.6 "End-User" means an individual, person, organization or entity that purchases a Licensee Product for his, her or its own personal or business purposes, and not for sublicense or redistribution to others.
- 1.7 "License Key" means an alphanumeric code unique to each copy of the WebObjects Materials that enables it to run on a computer when such code is inputted upon installation of the software program.
- 1.8 "Licensed Copy" or "Licensed Copies" means a copy (or copies) of the WebObjects Materials for which Licensee has purchased a license from Apple under this Agreement.
- 1.9 "Licensed System" means any computer designed to run the WebObjects Materials with a valid and unique License Key, and which is either owned and/or operated (i) by an End-User for its internal use, or (ii) by a third party as a web application server, provided that End User has a written agreement with such third party that protects Apple's interest in the WebObjects Materials at least to the same extent as the terms set forth in Exhibit B (Minimum Terms & Conditions - End-Users).
- 1.10 "Licensee Product" means the commercial application software product named and described by Licensee in Exhibit A hereof, which is developed using Apple's WebObjects development platform, relies upon Apple's WebObjects deployment environment to deploy on a Licensed System, and is licensed and/or sold by Licensee under its own trademark.
- 1.11 "Manufacturer" means an individual, person, organization or entity that reproduces, manufactures and assembles copies of Licensee Product that contain or otherwise incorporate the WebObjects Materials for Licensee, pursuant to an agreement with Licensee containing certain minimum terms as set forth below.

- 1.12 "Single Licensee Product" means (a) one Licensee Product, or (b) one or more Licensee Products, that may or may not be bundled with other third party software, provided that the Licensee Products and such other software (if any) are embedded or otherwise contained in the same physical medium (for example, a single CD).
- 1.13 "WebObjects Badges" mean the 'WebObjects' and 'Powered by WebObjects' badges depicted at the following URL:
<http://www.apple.com/about/webbadges/>.
- 1.14 "WebObjects Materials" means the complete runtime and electronic documentation comprising the deployment version of WebObjects 4.5.1 or later (as licensed by Apple to operate on one single or multi-processor Licensed System) explicitly excluding any compiler or headers included in said release.
- 1.15 "Updates" to the WebObjects Materials means all additions, updates, revisions, modifications, corrections, enhancements and future releases to the WebObjects Materials, made available to Licensee by Apple under this Agreement (if any).

2. GRANT OF LICENSES; RESTRICTIONS; OWNERSHIP

- 2.1 Object Code License. Subject to the terms and conditions of this Agreement, Apple hereby grants to Licensee, during the term of this Agreement, a non-exclusive, personal, non-transferable, non-assignable, revocable (in accordance with Section 9 below), right and license:
 - (a) to use, reproduce, copy and distribute each Licensed Copy of the WebObjects Materials only in its entirety and only in object code (machine-readable) form, except to the extent provided to Licensee in human-readable text form, solely as part of or otherwise bundled with a Single Licensee Product for use on a Licensed System; and
 - (b) to sublicense Distributors the right to distribute each Licensed Copy of the WebObjects Materials, only in its entirety and only in object code form, except to the extent provided to Licensee in human-readable text form, solely as part of or otherwise bundled with a Single Licensee Product for use on a Licensed System; and
 - (c) to sublicense Distributors and End-Users, and to sublicense Distributors to sublicense to End-Users, the right to use the Licensed Copy of the WebObjects Materials that is included as part of a Single Licensee Product on a Licensed System, in accordance with the terms of the End-User license agreement described in Section 2.3(a) below.
- 2.2 Additional Restrictions. The licenses granted by Apple to Licensee under this Agreement are subject to each of the following additional restrictions:
 - (a) Licensee shall not have the right to distribute the WebObjects Materials by themselves or otherwise on a stand-alone basis;
 - (b) Licensee may not reproduce the WebObjects Materials, or any portion thereof, in any country other than the following: Australia, Austria, Belgium, Canada, Denmark, France, Germany, Greece, Ireland, Italy, Japan, Luxembourg, Netherlands, New Zealand, Portugal, South Korea, Spain, Sweden, Switzerland, Taiwan, United Kingdom and the United States of America, without the prior written consent of Apple; and

- (c) Licensee agrees not to directly or indirectly alter, reverse engineer, disassemble or decompile the WebObjects Materials, except to the extent allowed by applicable local law.

2.3 Conditions Precedent to Licenses. Each of the license grants under this Agreement is expressly conditioned upon Licensee's and its Distributors' compliance with each of the following requirements:

- (a) All copies of the WebObjects Materials made and/or distributed by Licensee and its Distributors under this Agreement shall be accompanied and governed by an End-User license agreement that: (i) will be drafted so as to apply to the WebObjects Materials; and (ii) includes terms and conditions and third party acknowledgements that are substantially equivalent to, and that are no less materially protective of Apple's rights in the WebObjects Materials than those set forth in Exhibit B (Minimum Terms & Conditions - End-Users). In the United States and in other jurisdictions where there is an enforceable copyright covering the WebObjects Materials, such End-User license may be (1) a written agreement signed by the End-User, or (2) a written agreement, or a notice referring to such written agreement, on or accompanying the Licensee Product incorporating or otherwise bundling the WebObjects Materials or the package containing such software that is fully visible to the End-User before the package is opened or before the Licensed Product is usable, and that the End-User accepts by opening the package, using the Licensed Product or some other affirmative action. In all other jurisdictions, such license must be a written agreement signed by the End-User;
- (b) Licensee and its Distributors agree not to market the WebObjects Materials in such a way as to encourage any violation of the End-User license agreement;
- (c) With each unit of the WebObjects Materials authorized to be distributed with the Licensee Product, Licensee agrees to provide a unique License Key. The License Key may be inputted automatically with the installation of the WebObjects Materials. Alternatively, the License Key may be inputted manually by the End User during installation. Licensee may not use or associate a particular License Key for multiple units. The License Keys may be obtained by contacting Apple's Software Licensing group at the address set forth on the first page of this Agreement. Licensee and its Distributors agree to include a prominent notice on the End User license agreement stating that the License Key is uniquely associated with the copy of WebObjects Materials being licensed and prohibiting End Users from associating or using the License Key with any other copy of the WebObjects Materials or from redistributing the License Key in any manner. Licensee agrees that it will distribute and use each License Key solely as expressly permitted in this Agreement; and
- (d) The labeling and other requirements of Section 4.

2.4 Support; Updates. This Agreement does not obligate Apple to provide any technical support or Upgrades for the WebObjects Materials for Licensee, Distributors or End-Users. Should any party require technical support from Apple, such party shall negotiate separately the terms of any agreement to provide such support offered by Apple. If Apple decides in its sole discretion to provide Licensee with Updates of the WebObjects Materials under this Agreement, all such Updates will be considered as "WebObjects Materials" and shall be governed by the terms and conditions of this Agreement.

- 2.5 Ownership. Licensee acknowledges and agrees that the WebObjects Materials are proprietary to Apple and that Apple retains all rights, title, and interest in and to the WebObjects Materials, in so far as it has rights thereto, including without limitation copyrights, patents and other intellectual property and proprietary rights therein. Licensee agrees that this Agreement does not grant Licensee any title or other right of ownership to the licensed WebObjects Materials, or any title, license or other right of ownership to any Apple trademark. Except as expressly stated in this Agreement, no other rights or licenses, express or implied, are granted to Licensee by way of this Agreement.
- 2.6 Reproduction of WebObjects Materials. Licensee may enter into a manufacturing agreement with a Manufacturer to reproduce, manufacture and/or assemble copies of Licensee Product containing or otherwise incorporating the WebObjects Materials as authorized under this Agreement. In order to protect Apple's interest in the WebObjects Material, Licensee agrees that any manufacturing agreement entered between Licensee and Manufacturer will contain at a minimum the terms set forth in the Minimum Terms of Manufacture Agreement attached hereto as Exhibit C.
- 2.7 Sample Units/Copies. No later than ten (10) days prior to Licensee's Anticipated Release Date of any Licensee Product containing the WebObjects Materials, and subsequently upon Licensee's publication of any revision or new version of such Licensee Product, Licensee will deliver to Apple two (2) units or copies of each such Licensee Product and any related packaging and documentation. In the event Licensee anticipates that the stated Anticipated Release Date needs to be modified to accommodate a later release date, Licensee agrees to provide written notification to Apple of such later release date no less than ten (10) days prior to the stated Anticipated Release Date. Such later release date will then be considered the Anticipated Release Date under this Agreement. Apple may use such sample units for demonstration and/or quality assurance purposes, and to verify that Licensee is in compliance with the terms of this Agreement. These sample units/copies should be sent to Apple at the following address, or such address as Apple may subsequently notify Licensee in writing:

- 2.8 Promotional Activities. In connection with Apple's promotion of the WebObjects Materials, including, but not limited to the listing on its web site of third party applications running on the WebObjects platform, Licensee grants to Apple a worldwide non-exclusive royalty free license to publicly use (i) commercially available promotional material contained in or associated with the Licensee Product (including, but not limited to screen shots from the Licensee Product) and (ii) Licensee's name and all trademarks associated with the Licensee Product for making factual statements about Licensee Product's use of the WebObjects Materials. Apple agrees to make reasonable efforts to adhere to any trademark guidelines, as delivered in writing to Apple from time to time.
3. LICENSE FEES; RECORD KEEPING
- 3.1 License Fees. Licensee may choose to purchase licenses for the WebObjects Materials granted under Section 2.1 in single or multiple units/copies. For each

Licensed Copy purchased by Licensee, Licensee agrees to pay Apple the license fee indicated in Exhibit A hereof. Licensee agrees that it and its Distributors will not use, reproduce, sublicense or distribute copies of the WebObjects Materials in excess of the number of Licensed Copies purchased and paid for by Licensee under this Agreement. Copies of the WebObjects Materials used internally by Licensee will be included in and will count towards the number of Licensed Copies purchased.

- 3.2 Initial Licensed Copies; Additional Copies. The initial number of Licensed Copies to be purchased by Licensee is the number indicated by Licensee in Exhibit A hereof. Licensee shall also indicate in Exhibit A the aggregate amount of the initial license fee. Such initial license fee shall be paid by Licensee concurrently with Licensee's execution of this Agreement, and submitted together with two (2) signed originals of this Agreement, in accordance with the payment instructions set forth in Section 3.4 below.
- 3.3 During the term of this Agreement, Licensee may also purchase additional Licensed Copies. To do so, Licensee must complete, sign and submit a written Amendment to Licensed Copies, in substantially the form attached hereto as Exhibit D, to Apple, attention: WebObjects Software Licensing department noted in Section 3.4 below, stating the additional number of Licensed Copies being purchased, and accompanied by payment of the aggregate amount of Per Unit Licensed Copy Fees indicated in Exhibit A. Once Licensee has submitted its written Amendment to Licensed Copies and paid the applicable license fee to Apple, Apple will notify Licensee of the License Keys applicable to the Licensed Copies and Licensee will be authorized to reproduce and distribute the additional Licensed Copies. All such additional Licensed Copies will be subject to the terms and conditions of this Agreement. Apple, however, will give no credit or refund, for any purchased but "unused" Licensed Copies that exist as of the date of expiration or termination of this Agreement, subject to the provisions of section 9.3(b).
- 3.4 Payment. All payments by Licensee under this Agreement will be made in United States Dollars, either (i) by certified check or money order drawn on a U.S. registered bank made payable to "Apple Computer, Inc." and sent to Apple at the following address, or such address as Apple may subsequently notify Licensee in writing:

- 3.5 Record-Keeping. During the term of this Agreement and for a period of three (3) years thereafter, Licensee agrees to keep and maintain detailed, complete and accurate records of its and its Distributors' use (including internal use), reproduction, sublicensing and distribution of the WebObjects Materials. Such records will contain at least the following information in reasonable detail: (a) total number of Licensed Copies exercised over relevant period (quarter, year, etc.); (b) total number of Licensed Copies used, reproduced, sublicensed and/or distributed by Licensee and its Distributors in the same period; (c) aggregate number of Licensed Copies exercised to date; (d) total number of copies of the WebObjects Materials used, reproduced, sublicensed or distributed by Licensee and its

Distributors to date; (e) any shortfall or overflow of Licensed Copies; and (f) licensee fees paid to Apple to date.

- 3.6 Right to Audit. Apple will have the right, directly or through the use of an independent auditor, at Apple's expense and upon reasonable notice to and during the normal business hours of Licensee, during the term of this Agreement and for a period of one (1) year thereafter, to audit Licensee's records for the purpose of determining whether Licensee is in substantial compliance with the terms of this Agreement regarding the protection and authorized use of the WebObjects Materials ("Obligations"), and/or verifying the accuracy of license fees payable and/or paid under this Agreement. All such Licensee records will be considered "Confidential Information" of Licensee and will be kept confidential by Apple and its auditors in accordance with the terms of this Agreement. If, as a result of such audit, an underpayment by Licensee of five percent (5%) or more is found, Licensee will reimburse Apple for the reasonable cost of such audit within thirty (30) days of such finding and in addition will pay Apple any sums owed Apple identified in the audit. If Licensee's reports or payments include any inconsistencies or mistakes, Licensee will immediately rectify such statements and will immediately make any payments required by such rectification. Failure to pay such license fees when due as provided in this Section will be grounds for termination of this Agreement. In the event that an overpayment is found during the term of this Agreement, Licensee will be entitled to a credit to offset such overpayment; provided, however, that no credit or refund will be given by Apple for any "unused" Licensed Copies that exist as of the date of expiration or termination of this Agreement. Licensee shall pay all amounts when due, and, if applicable, any amounts not paid when due shall accrue interest at the lower of one and one-half percent (1.5%) per month or the maximum rate allowable under law, from the date when the payment should have been paid and ending when paid.
- 3.7 Taxes. The licensee fees payable by Licensee hereunder are exclusive of taxes and Licensee will be responsible for paying any applicable use, sale, withholding tax imposed by the taxing authority of the country in which Licensee Products (into which the WebObjects Materials are included) are distributed and/or licensed.

4. LABELING; TRADEMARKS

- 4.1 Proprietary Legends. As a condition of Apple's license grant in Section 2, Licensee agrees to:
- (a) not remove any copyright notices or proprietary or other legends contained on or within the WebObjects Materials and to reproduce all such notices and legends on all copies of the WebObjects Materials made by or for Licensee;
 - (b) include the following copyright notice, "©1988- Apple Computer, Inc. All rights reserved." conspicuously on or in the installation dialog box, diskettes, CD-ROMs, documentation and on each copy of the WebObjects Materials made by or for Licensee;
- 4.2 Trademarks. Except as expressly provided in this Agreement or as otherwise agreed to in writing by an authorized representative of Apple, this Agreement does not authorize Licensee to use the trade name "Apple Computer, Inc.", or any trademark, trade name, service mark or logo of Apple in any of Licensee's advertising or in any other way whatsoever, including domain names. Licensee may only use Apple trademarks as necessary to make factual statements (in its advertising, marketing, distribution and sale of Licensee Products) that the Licensee Products are compatible with certain Apple products. Any such notice shall not

make it appear that Licensee Products originate from Apple, and Licensee shall be solely responsible for the service and support of Licensee Products.

4.3 Trademark Registration. Upon Apple's reasonable request and at Apple's expense, Licensee agrees to execute all applications for trademark registrations, assignments or other applicable documents and to perform acts reasonably necessary and requested by Apple for Apple to secure and maintain any and all trademark rights to any Apple trademarks in any country in which Licensee is distributing the WebObjects Materials.

4.4 Web Badges. Subject to Licensee's acceptance of the Apple Technology Web Badge Trademark License and Apple Technology Web Badge Usage Guidelines, Apple grants to Licensee, during the term of this Agreement, a non-exclusive right to display the WebObjects Badges in user interfaces created or using the WebObjects Materials.

5. CONFIDENTIALITY

Each party will protect the other's Confidential Information from unauthorized dissemination and use with the same degree of care that each such party uses to protect its own like information, and at a minimum with a reasonable degree of care. Neither party will use the other's Confidential Information for purposes other than those necessary to directly further the purposes of this Agreement. Neither party will disclose to third parties the other's Confidential Information without the prior written consent of the other party. The confidentiality obligations of this Section 5 will survive the termination or expiration of this Agreement.

6. WARRANTY

Apple warrants to Licensee for a period of ninety (90) days from the date of delivery of the WebObjects Materials ("Warranty Period"), that the WebObjects Materials shall operate substantially in accordance with the functional specifications of the documentation accompanying the software, if used on a machine for which it is designed. If during the Warranty Period, the WebObjects Materials does not operate as warranted, provided Licensee notifies Apple within the Warranty Period, at Apple's election, a replacement or refund of the amounts paid by Licensee for the license of that copy of the WebObjects Materials will be provided. Licensee agrees that the foregoing constitutes its sole and exclusive remedy for breach by Apple and any third party licensor of any warranties made under this Section. **OTHER THAN AS PROVIDED IN THIS SECTION, APPLE MAKES NO WARRANTIES WHATSOEVER, EXPRESS OR IMPLIED, REGARDING THE WEBOBJECTS MATERIALS, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY AND/OR FITNESS FOR ANY PARTICULAR PURPOSE.** Neither Licensee, its employees, agents, nor distributors have any right to make any other representation, warranty or promise with respect to the WebObjects Materials.

7. LIMITATION OF LIABILITY

IN NO EVENT SHALL EITHER PARTY BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES RESULTING FROM THIS AGREEMENT, (EXCEPT AS MAY BE PROHIBITED BY LAW WITH RESPECT TO DAMAGES RESULTING FROM DEATH OR PERSONAL INJURY).

8. INDEMNIFICATION

Licensee shall indemnify and hold Apple harmless from any and all damages, liabilities,

costs and expenses (including but not limited to attorneys' fees and costs of suit) incurred by Apple, its subsidiaries, affiliates, directors, officers, employees, agents and/or independent contractors as a result of any claim, action, suit proceeding or judgment to the extent it arises out of or is connected in any manner with Licensee's and/or its Distributors' use, reproduction, sublicensing and/or distribution of the WebObjects Materials, a Manufacturer's reproduction, manufacture or assembly of the WebObjects Materials (as included as part of a Licensee Product), or the combination of the WebObjects Materials with Licensee Product(s). Apple shall promptly notify Licensee of any such claim and shall provide Licensee with reasonable cooperation and assistance in connection with the defense of such claim.

Apple will, at its expense, defend Licensee against any claim that WebObjects Materials supplied hereunder infringes any United States copyright, trade secret, trademark, or patent currently issued. Apple will pay all costs, damages and attorney's fees that a court finally awards as a result of such claim. To qualify for such defense and payment, Licensee must: (a) update all copies of the WebObjects Materials with the most current commercial release of the WebObjects Materials, (b) give Apple written notice within fifteen (15) days of any such claim; (c) allow Apple to control, and fully cooperate with Apple in the defense of such claim and all related settlement negotiations; and (d) permit Apple at its option and expense either to procure the right to continue marketing and using the WebObjects Materials or to replace or modify it so that it becomes non infringing, and if neither of the foregoing alternatives is available on terms which are reasonable in Apple's judgment, Licensee will return all copies of the WebObjects Materials in its possession on written request by Apple and cease licensing, sublicensing, selling or otherwise distributing such infringing products, or cease using such infringing trademark. Apple shall have no obligation with respect to any claim based upon the alteration or modification of any software supplied by Apple hereunder. The foregoing indemnity states Apple's entire obligation to Licensee and Licensee's sole and exclusive remedy with respect to infringement of any patent, copyright, trade secret, trademark or other proprietary rights, and is made in lieu of, and Apple hereby disclaims, any warranty of title or warranty that the WebObjects Materials is delivered free of any claim by any third party for infringement or the like.

9. TERM AND TERMINATION

- 9.1 Term. The Effective Date of this Agreement shall be the date of Apple's execution and each additional term, if renewed by Licensee, shall begin on the anniversary of the Effective Date ("Anniversary"). The initial term will be three (3) years and the Agreement will renew for additional one (1) year terms, provided Apple receives from Licensee written notice of its intent to renew within sixty (60) days prior to the Anniversary. However, this Agreement shall not renew should any of the following events occur: (i) the Agreement is terminated earlier pursuant to Section 9.2; (ii) Apple provides written notice to Licensee of its intent to terminate the Agreement on the Anniversary, no less than sixty (60) days prior to the expiration of the initial term or any renewal term; (iii) Licensee fails to timely pay any payments due under this Agreement; or (iv) prior to the Anniversary date, Licensee provides written notice to Apple of its intent to terminate the Agreement.
- 9.2 Termination for Cause. Either party will have the right to terminate this Agreement and the licenses granted hereunder for cause immediately upon written notice to the other at any time if:
- (a) The other party is in material breach of any warranty, term, condition or covenant of this Agreement other than those contained in Section 5

(Confidentiality) and fails to cure that breach within thirty (30) days after written notice of that breach and of the first party's intention to terminate; or

- (b) The other party is in material breach of any warranty, term, condition or covenant of Section 5; or
- (c) The other party: (i) Becomes insolvent; (ii) Fails to pay its debts or perform its obligations in the ordinary course of business as they mature; (iii) Admits in writing its insolvency or inability to pay its debts or perform its obligations as they mature; or (iv) Makes an assignment for the benefit of creditors.

9.3 Effect of Expiration/Termination.

- (a) Upon termination of this Agreement for cause by Apple pursuant to Section 9.2 above: (i) all licenses granted to Licensee by Apple hereunder shall forthwith terminate; (ii) Licensee will immediately return to Apple all copies of the WebObjects Materials reproduced pursuant to this Agreement and all Confidential Information of Apple that is in Licensee's possession or control; and (iii) Licensee and its Distributors and Manufacturers will immediately stop any further use, reproduction, incorporation, sublicensing and/or distribution of the WebObjects Materials. Within ten (10) days after the expiration of this Agreement or termination of this Agreement by Apple for cause, an authorized officer of Licensee will certify in writing to Apple that: (1) all copies, whole or partial, of the WebObjects Materials that were created pursuant to this Agreement and are in Licensee's possession or control have been returned to Apple; and (2) Licensee is otherwise complying with the requirements and conditions of this Section 9.3(a).
- (b) In the event of termination other than for cause by Apple pursuant to Section 9.2 above, Licensee may distribute the WebObjects Materials as specified in Section 2 for up to one hundred and eighty (180) days from the date of termination. At the expiration of the aforesaid one hundred and eighty (180) day period, (i) all licenses granted to Licensee by Apple hereunder shall forthwith terminate; (ii) Licensee will immediately return to Apple all copies of the WebObjects Materials reproduced pursuant to this Agreement and any and all Confidential Information of Apple that is in Licensee's possession or control; and (iii) Licensee and its Distributors and Manufacturers will immediately stop any further use, reproduction, incorporation, sublicensing and/or distribution of the WebObjects Materials. Within ten (10) days after the one hundred and eighty (180) day period, an authorized officer of Licensee will certify in writing to Apple that: (1) all copies, whole or partial, of the WebObjects Materials that were created pursuant to this Agreement and are in Licensee's possession or control have been returned to Apple; and (2) Licensee is otherwise complying with the requirements and conditions of this Section 9.3(b)
- (c) Notwithstanding the foregoing, upon the expiration or any termination of this Agreement, all End-Users who have been granted rights to the WebObjects Materials by Licensee in accordance with this Agreement and within one hundred and eighty (180) days after the date of termination as described in Section 9.3(b), will be permitted to continue to enjoy such rights for so long as such End-Users are not in default of their End-User license agreement.
- (d) Also upon the expiration or any termination of this Agreement, subject to section 9.3(b) above, each party will be released from all obligations and liabilities to the other occurring or arising under this Agreement after the date of such termination, except that the provisions of Sections 1 (Definitions), 2.3

(Conditions Precedent to Licenses), 2.5 (Ownership), 3 (License Fees; Record Keeping), 4.3 (Trademark Registration), 5 (Confidentiality), 6 (Warranty), 7 (Limitation of Liability), 8 (Indemnification), 9.3 Effect of Expiration/Termination) and 10 (General Terms) will survive such termination or expiration. Apple will also retain the right to receive any and all license fees to which it is entitled under Section 3 of this Agreement that remain unpaid at the time of expiration or termination, and the right to audit pursuant to Section 3.6 of this Agreement. Neither expiration nor termination of this Agreement will relieve either Licensee or Apple from any liability arising from any breach of this Agreement. Neither party will be liable to the other for damages of any sort solely as a result of terminating this Agreement in accordance with its terms, and termination of this Agreement will be without prejudice to any other right or remedy of either party.

10. GENERAL TERMS

- 10.1 Representations. Licensee represents and warrants to Apple that it is free and has the power and authority to enter into this Agreement and that Licensee is not a party to nor will it enter into any agreement that is inconsistent or in conflict with any term(s) of this Agreement. Apple represents and warrants to Licensee that it is free and has the power and authority to enter into this Agreement.
- 10.2 Notices. Any notice required under this Agreement will be given: (a) when delivered personally; (b) by confirmed facsimile; (c) two (2) business days after having been sent by overnight courier; or (d) five (5) business days after having been sent by registered or certified mail, return receipt requested, postage prepaid, to the addresses for the respective parties set forth on the first page of this Agreement, as such address(es) may be changed by written notice from time to time to the other party.
- 10.3 Assignment. This Agreement may not be assigned by Licensee, nor may any of the rights or obligations of Licensee be assigned, transferred or delegated, in whole or in part, by any means (including without limitation, assignment or transfer by operation of law or in the course of acquisition, merger, sale of Licensee or otherwise) without the prior written approval of Apple. For the purposes of this Section, a change in the person or entities who control fifty percent (50%) or more of the equity securities or voting interest of Licensee shall be considered an assignment of Licensee's rights. Apple may assign its rights and obligations under this Agreement without Licensee's consent.
- 10.4 Relationship of Parties. This Agreement will not be construed as creating an agency, partnership, joint venture or any other form of legal association between the parties, and both parties will not represent to the contrary, whether expressly, impliedly, by appearance or otherwise.
- 10.5 Equitable Relief. Because Apple and Licensee will each have access to and become acquainted with Confidential Information of the other, the unauthorized use or disclosure of which would cause irreparable harm and significant injury which would be difficult to ascertain and which would not be compensable by damages alone, each of Apple and Licensee agrees that, in addition to any other remedy available to the owner of such Confidential Information at law or in equity, the confidentiality provisions of this Agreement shall be enforceable by such owner under the provisions of the California Uniform Trade Secrets Act, California Civil Code Section 3426, as amended. Further, if Licensee fails to fulfill its Obligations (as defined in Section 3.6), Apple shall have the right to injunctive relief in addition to any other remedy.

- 10.6 Export. Licensee acknowledges that the laws and regulations of the United States restrict the export and re-export of commodities and technical data of United States origin, and Licensee certifies that it will not distribute the WebObjects Materials in contravention of any applicable laws or regulations relating to export control, including but not limited to the United States Export Administration Act and associated regulations. In particular, but without limitation, the WebObjects Materials may not be exported or reexported (a) into (or to a national or resident of) any U.S. embargoed country; (b) to anyone on the U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Department of Commerce's Table of Denial Orders; or (c) without appropriate U.S. and foreign government licenses.
- 10.7 Restricted Rights. Licensee will (a) identify the WebObjects Materials and related documentation in all proposals and agreements therefor and (b) identify or mark such software and documentation provided pursuant to any agreement with the United States Government, as necessary to obtain protection substantially equivalent to that afforded to commercial computer software and related documentation developed at private expense and provided with Restricted Rights as set forth in subparagraph (c) of FAR § 52.227-19, entitled Commercial Computer Software - Restricted Rights. In contracts with U.S. Dept. of Defense agencies, Licensee will provide that the government's rights in the WebObjects Materials, supporting documentation, and technical data are governed by the restrictions in DFARS § 252.227-7015, entitled Technical Data -- Commercial Items, and DFARS § 227.7202.
- 10.8 No Waiver; Severability. Failure by either party to enforce any provision of this Agreement will not be deemed a waiver of future enforcement of that or any other provision. If for any reason a court of competent jurisdiction finds any provision of this Agreement, or portion thereof, to be unenforceable, that provision of the Agreement will be enforced to the maximum extent permissible so as to effect the intent of the parties, and the remainder of this Agreement will continue in full force and effect.
- 10.9 Construction. The parties and their respective counsel have negotiated this Agreement. This Agreement will be interpreted fairly in accordance with its terms and without any strict construction in favor of or against either party.
- 10.10 Governing Law. This Agreement will be governed by the laws of the State of California, except that body of California law concerning conflicts of law. Any litigation or other dispute resolution between the parties relating to this Agreement shall take place in the Northern District of California. The parties hereby consent to the personal jurisdiction of, and venue in, the state and federal courts within that District with respect to this Agreement.
- 10.11 Entire Agreement. This Agreement, including all Exhibits, constitutes the entire agreement between the parties with respect to the subject matter hereof, and supersedes and replaces all prior or contemporaneous understandings or agreements, written or oral, regarding such subject matter. Except for the Amendment(s) to Licensed Copies described in Section 3.3 above, no other amendment to or modification of this Agreement shall be binding unless in writing and signed by a duly authorized representative of both parties. Apple and Licensee agree that all Amendment(s) to Licensed Copies shall be binding and effective once signed by Licensee, and will not require Apple's signature to be

deemed binding and effective.
